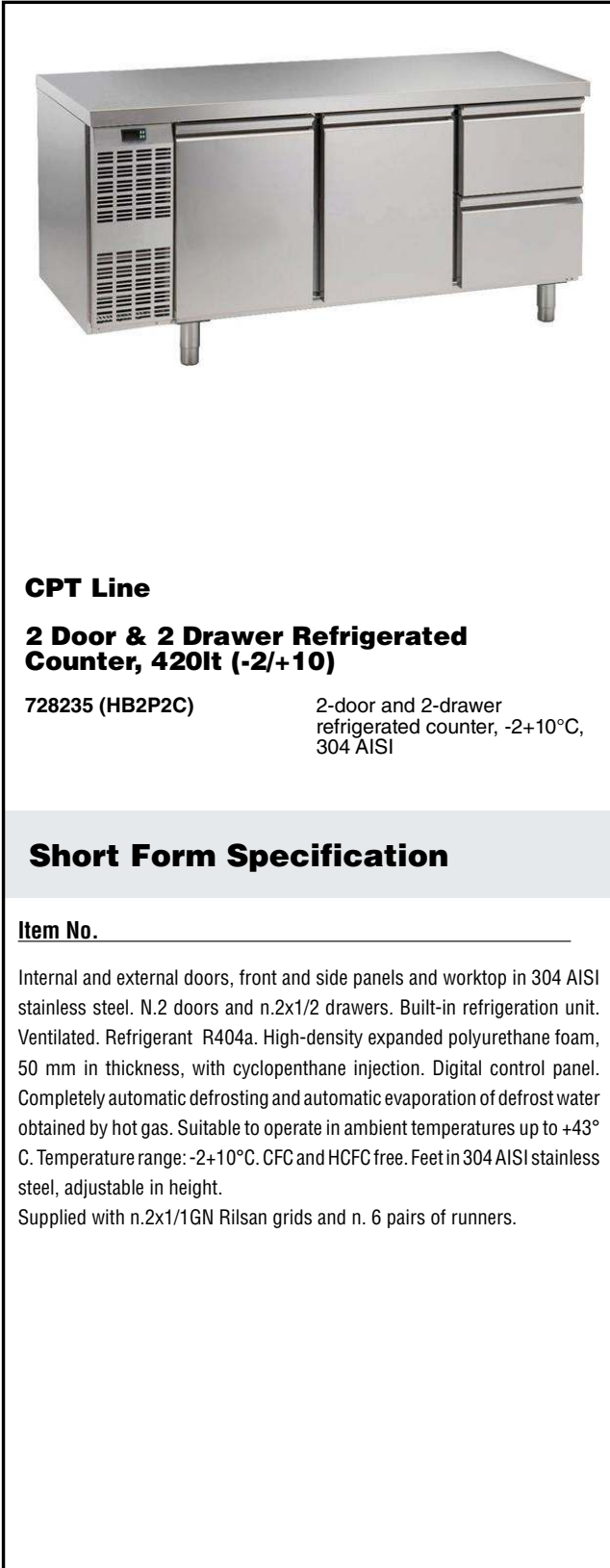

Completely automatic defrosting and automatic evaporation of defrost water obtained by hot gas. Suitable to operate in ambient temperatures up to +43° C. Temperature range: -2+10°C. CFC and HCFC free. Feet in 304 AISI stainless steel, adjustable in height. Supplied with n.2x1/1GN Rilsan grids and n. 6 pairs of runners.

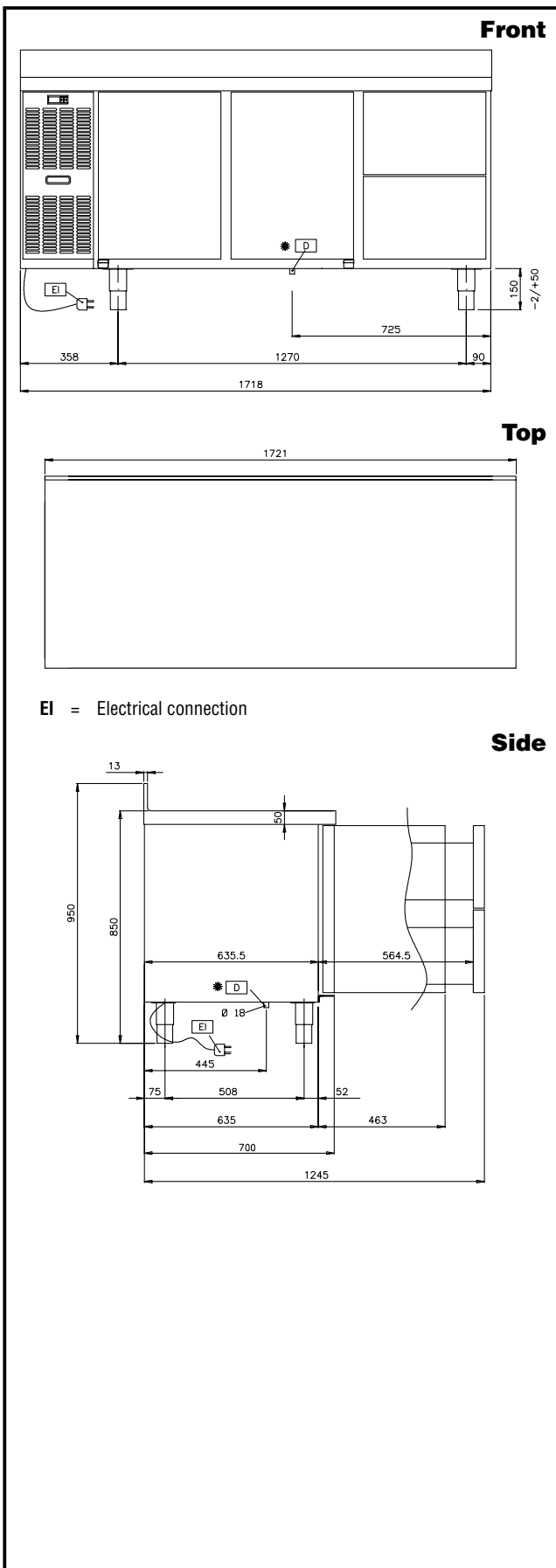
